- 1. The unaudited standalone financial results of the Company for the half year ended 30th Sep, 2020 have been prepared in accordance with the Indian Accounting Standards ("Ind As") as prescribed under section 133 of the Companies Act, 2013 read with the Companies (India Accounting Standards) Rules, 2015, as ammended.
- 2. The figures of the last quarter are the balancing figures between audited figures in respect of full financial year upto March 31, 2020 / March 31, 2019 and the unaudited published year-to-date figures upto December 31, 2019 / December 31, 2018 being the date of the end of the third quarter of financial year respectively which were subject to limited review.
- 3. The above unaudited standalone financial results of the Company for the half year ended 30th Sep, 2020 have been reviewed by the Audit Committee on 12th Sep, 2020 and thereafter approved by the Board of Directors at their meeting held on 12th Sep, 2020.
- 4. The Company has adopted Ind AS 116 "Leases" effective April 01, 2019, using modified retrospective method. The Company has applied the standard to all its leases with the cumulative impact recognized on the date of initial application i.e. April 01, 2019.
- 5. The Company has made an assessment of possible impacts that may result from the COVID-19 pandamic on the carrying value of current and non surrent assets and forecast transactions relating to hedging, considering the internal and external information available till date and to the extent determined by it. The eventual impact of COVID-19 may differ from that estimated as at the date of approval of these financial results, and the Company will continue to closely monitor material changes to future economic conditions.
